**2015 Dog/Cat License Application**

The Village of Spring Valley requires all dogs or cats kept within the Village to be licensed. Dog and cat licenses are due and payable on or before **April 1<sup>st</sup>** of each year. Village of Spring Valley ordinance 7-1-1 requires that the owner of dogs and cats more than 5 months of age shall obtain a license annually, on or before April 1<sup>st</sup> or on the date the dog or cat becomes 5 months of age.

**A Certificate of Vaccination is required and must be presented when you apply for the license**
