Police: YTD statistics for 2017 are about the same as last year. Holiday parade went well; additional coordination and day/time will be discussed for next year. Shop With A Cop went well. Stray dog procedure was developed. Help with a school mentoring program is being considered.

Library: for 2017: 33,000+ books were issued; 250 kids/week visited the library; 100 patrons per year are being added to the membership over the past few years; 767 SV cardholders, 1418 total memberships from the surrounding area including River Falls, Plum City, Glenwood City. 2018 will have a full time librarian.
