Village Board – Regular meeting minutes
March 4, 2020



Call to Order: President pro-tem Ducklow called the meeting to order at 6:15 p.m. in Council Chambers Village Hall.

Approval of Minutes: Motion (Falde/Jacobson) to approve minutes 1/27, 2/19, 2/10, 1/6 Carried.

Appearances: Paula Lugar appeared to explain the gerrymandering referendum that will be on the April ballot.

CVTC was present to give a presentation on the upcoming referendum for Facilities Development Action items:

- **2) Motion (Vorlicek/Jacobson)** to approve the meter upgrade DSG Option 1 not to exceed \$175,000. Vote: Ayes: Ducklow, Falde, Huepfel, Jacobson, Vorlicek. Nays: none. Absent: Brunkhorst, O'Connell. Carried. Drive-by system, mandatory cross-connection inspections will not need to be done for 20 years, freeze lines can be detected, data will be available on daily consumption, pipe burst and dry meters will be detected. Current meters are approaching life expectancy. Installs will be part of purchase; they will assume liability.
- 3) Tabled. Questions regarding emotional support dogs for reading need to be addressed.
- 4) Precon meeting Monday; Eau Galle Rd design continues, 2020 bridge will be done, 2021 EG Rd will be done; Van Buren big grant was not awarded to village, discretionary grant should be coming out soon; Graham has started reporting with full licensing, Mike moving forward on his licensing; LRIP swap for Glade
- 5) Marketing personnel needs to be adjusted; inspection of pantries needs to be done since renovation is no longer being done. Special meeting was recapped.
- 6) Motion (Jacobson/Falde) to approve pay requests and Treasurer's report. Carried.
