FROM THE ADMINISTRATOR'S OFFICE:

2024-2025 TAX SEASON is underway, everyone should have their tax bill by now. If you didn't get yours, please call the Village office and we can print you a new one. First installment is due by January 31st 2025 payable to Village of Spring Valley. If you want to pay more than that or the full amount it will still be payable to the Village. Only payments made after February 7th 2025 will be payable to Pierce County Treasurer. Pierce County will send a reminder letter in June for any balance which will be due by July 31st, 2025.

Point n Pay is being phased out for property tax purposes only, you can still make all other amounts due to the Village on PnP. Property taxes can be paid online at: <https://public-portal.co.pierce.wi.us/Login> click on "Guide - How to Make a Tax Payment" and follow the instructions.

All dogs and cats must be registered by April 1, 2025. If you don't have a registration form you can find one on the Village web site www.springvalleywi.com or stop in the Village hall, there is a rack of forms just outside our door and you can find one there. A form was also mailed with every tax bill. **LANDLORDS** please make sure your renters register their pets. As owner, you are ultimately responsible for that dog or cat. Owners who fail to license their dogs and cats are subject to a fine. A current Vaccination Certificate must be on file for your pet. Please make sure you are providing the actual certificate. EVERYONE WANTS THEIR STREET PLOWED FIRST!!

Unfortunately we can't all be first. Please be patient during a snow event, everyone is doing their best. Roads are

plowed in a specific order as determined by Public Works to be more urgent and heavily traveled than side streets.

Remember there is no parking on Village streets between 2 a.m. and 7 a.m. until April 1st, 2025. If you have overnight guests who need to park in the street please notify Officer Lilly for a permit.

After a snowfall, check the condition of any hydrant on your block. If needed, would the fire department be able to access and use the hydrant near your home? If not, dig it out! Also check your mailbox; it is your responsibility to keep it clear for mail delivery.



IT IS A HOMEOWNER'S RESPONSIBILITY TO SHOVEL THEIR WALK

Each homeowner is responsible for keeping their sidewalk clear of all snow and ice. If snow accumulates on a sidewalk due to natural means and/or by any other means you have 24 hours from the time the snow ceases to accumulate on the sidewalk to clear it. If ice has formed on a sidewalk in such a way that it cannot be removed, the owner, occupant or person in charge of the sidewalk shall keep the sidewalk sprinkled with sand and/or salt to permit safe travel by pedestrians. If you fail to remove the snow and/or ice after you have been notified the Village will do so at a minimum charge of \$100.00.

KEEP GARBAGE CANS, BASKETBALL HOOPS, AND ANY OTHER OBSTACLE OFF THE STREETS!

These free-standing items should be out of the Public Works Right of Way. If our winter plow help needs to go around or get out of snow removal equipment to move things in the ROW, it causes delays for everyone else.

Please do NOT shovel or blow snow into the street. This creates a hazardous condition for motorists. In addition village ordinances prohibit this action and doing so may result in a fine.
