



# Notice: Solicitors Must Have a Village Permit

Recent storms have led to an increase in solicitors going door-to-door offering services for roof, siding, and other stormrelated repairs. Please be aware that **all solicitors must have a permit issued by the Village of Spring Valley** in order to operate within the Village. We receive information on all individuals who will be canvassing neighborhoods and conduct background checks to ensure they are reputable and safe for our residents.

If someone knocks on your door offering services or asks to inspect your roof, please ask to see their Village-issued solicitor's permit. This official permit will be signed by the Village Administrator and stamped with the Village seal.

If they do not have this permit, **do not engage, please refer them to the Village office,** they may be fraudulent. Your safety is our priority. If you have any concerns or encounter unpermitted solicitors, please contact the Village office.

# **SUMMER ORDINANCE REMINDERS:**

- 58-436 Boats and RVs should be parked inside an enclosed structure, outside on a hard surface or well-drained gravel pad under certain circumstances.
- 38-82 Open burning prohibited with certain exceptions
- 58-594 Swimming pools require a permit unless they are less than 18 in. deep.
- 18-7 Lawn length should not exceed 6 inches.
- 58-593 Fences: there is no permit required for fences but there are guidelines. Height is limited to 6' in back yard and 3' on side yard for corner lots. A fence cannot be in a front yard. Specific setbacks are in place.

#### BEAR SIGHTINGS IN SPRING VALLEY

The Village is aware of recent bear sightings in Spring Valley. Several residents have reached out with concerns and requests for removal. We have contacted the Pierce County Conservation Warden and were told that they do not remove or relocate bears.

The best course of action is prevention. Residents are strongly encouraged to eliminate food sources that may attract bears. This includes:

- Removing bird feeders
- Storing bird seed indoors or in sealed containers
- Securing garbage and compost bins

By working together and taking these precautions, we can help reduce bear activity in residential areas. Thank you for your cooperation and continued vigilance.

We are undertaking a multi-phase project to revitalize and improve one of our community playgrounds—a space that brings joy, activity, and connection to countless children and families.

#### Phase 1: Immediate Repairs & Beautification

- Repairing the existing large playground structure
- Replacing the broken slide that has been removed
- Removing broken and unsafe equipment
- Planting shrubbery along the alley fence line
- Adding two shade trees for a greener, cooler space

#### Phase 2: Surface Improvements (Estimates in progress)



- Removing the existing gravel
- Replacing it with a more child-friendly surface (e.g., wood chips or grass)
- Leveling the area to align with the curb for safety and accessibility

Phase 3: Creating a Reading Corner—Designing a shady, quiet space for both children and adults to relax and read. Phase 4: Swing Installation—Adding a set of swings—estimated cost: \$12,000 Phase 5: New Playground Structure—Replacing the current, well-worn playground equipment with a brand-new structure – Estimated cost: \$50,000+

Each phase brings us closer to a safer, more inclusive, and more enjoyable environment for our children. We are asking for your help—whether through donations, volunteering, or spreading the word—to make this project a reality.
